All present liked the option, but agreed that there would have to be an opinion from the Community Council. M.W. to take suggestion to the next Community Council meeting.

Mary Cramb has seen a similar tree in use locally and agreed to contact the business to ask how they found it with regard to weather and wear. The lights can be seen from a fair distance.

### Action, M.C.

Mike reported that the Community Council would be managing this year's Christmas Light display in the Village.

The new net for the MUGA is overdue, but is promised in the next couple of weeks.

Raised bed in Allanvale Road has not been looked at, as yet .

Garth's plaque has been ordered and Sylvia contacted.

Nativity Scene. M.W will ask for volunteers to refurbish via Community Web site. If no volunteers come forward, then it will be scrapped.

## **General Report:**

Douglas reported that the Dry Stone Walling Association had repaired the walls at Blairforkie Drive. He proposed that we send them a donation of £150 for their work. The proposal was agreed.

An article in the Stirling Observer last month highlighted some of the work we do. Douglas received a letter from Stephen Kerr, Member of Parliament for Stirling, as a result of this, thanking us for our work. The letter is on file.

A large planter has been donated to the group. It is being stored in the container until we find a use for it.

The barrel at the Station has been removed, as in poor condition.

A visit to the Memorial Park from the Green Flag judges last week went well.

### **Treasurers Report.**

Our funds are healthy after a very successful Plant Sale and Coffee morning.

We are awaiting invoices from Homesteads for baskets, plants and top soil.

There has been no refund of VAT from Stirling Council to date. Alex will contact them again.

### Baskets and planters.

The majority of the barrels and planters have been planted.

The baskets are due to go up next week. It was suggested that this should be done over two days, Sunday and Monday, and in the afternoon rather than the evening. This was approved.

Stirling Council have approved our grant of £500 for new Promenade planter.

The planters at the Houff need repairing . A decision was taken to replace them with the larger of the Ambrol barrels.

A basket for one local business was declined as they feel a barrel is more suitable. A decision was taken to move one of the existing barrels to this location.

FOBOA signs to be ordered to fit to all of our planters and baskets. Action. E.R.

#### **Station:**
